

Our goal is to provide a facility where people can meet Jesus through a safe and memorable camp experience.

Check In:

- Check-In is 3 p.m. **If available**, you may set up earlier in the day and day use fees will apply. If you require setup the day before, reserve the setup day to guarantee availability.
- Camp/church groups must provide a Certificate of Insurance with Camp Dellwater listed as Additional Insured. This must be on file during your stay.

Check Out:

- Check-Out is 12 p.m. **If available**, you may stay later, and day use fees will apply.
- The activity sheet is due before you leave (with payment, unless advance arrangements are made).

Damages:

- You will be charged for damages beyond normal wear and tear.
- It is a violation of Minnesota law and the State Fire Code to tamper with smoke alarms or fire extinguishers. Your group will be assessed a \$250 fine and law enforcement will be contacted for anyone caught tampering with them.

Smoking/Drugs/Alcohol:

- No alcohol or drugs in camp. Violators are asked to leave immediately.
- Smoking—outside only. Do not throw cigarettes on the ground.

Pets:

- No pets allowed due to liability & health regulations.

Lights Out:

- Lights Out/Quiet from 12 a.m. (or earlier) to 6 a.m.

Maintenance:

- Maintenance personnel are on-call during your stay.

Telephone:

- A telephone is available for emergencies – see Caretaker.

Group Responsibilities:

- You will provide food service personnel, lifeguards and nurses according to your needs & insurance requirements, certification is recommended.
- You are responsible for the safety of your group.

Keys:

- The group leader will be given keys for: Activity Center Kitchen, Nurse Cabin, Office, Rec Shacks and WaterSlide pump. Return at checkout.
- Please keep locked when not attended. You are responsible for missing/damaged items.

Facilities:

- The house, shed, and shop are for staff use only.
- Areas behind the shower house are off limits.
- Beyond the beach and lodge is private property; please stay on the camp grounds.

Camp Cleaning:

- You are responsible for daily kitchen, dining room and activity center kitchen cleaning. Camp Staff will clean restrooms, showers, and empty garbage daily, and clean/sanitize after your stay.
- You are responsible to wash/put away dishes prior to departure.
- Please keep cabins clean.

Game Room:

- Adult Supervision is required in the Game Room anytime it is in use.

Recreation Equipment:

- Basketballs, Volleyballs, Soccer balls and Horseshoes are in the Rec Shack near the Basketball court.
- Softballs, bats and gloves are located in the Ball Shack near the activity field.

- All sports equipment must be returned neatly in the proper Shack after use and before you leave.

Waterfront:

- Don't litter in the lake.
- Lifejackets, paddles and float toys are in the Beach Shack. Put away after use.
- Tether paddle boats to the hitching rail after each use.
- Turn canoes upside down on shore after use.
- No Running or diving on the shore docks.
- Waterfront is to be used during daylight hours only.
- Properly fitted life jackets required for all watercraft use and for non-swimmers.
- Adult Supervision required at the beach when in use.
- The Pontoon is available for use by rental camps. Charge is \$5.00 per gallon of gas. Check the box on the reservation if you plan to use.

Waterslide:

- Contact the Caretaker for instruction on pump use. Damage due to improper use can cost thousands and you will be charged for damages. Camp staff will operate on request.
- One at a time; wait until the last person leaves the base of the slide before starting.
- Use in daylight hours only.
- Two adults are required when in use – at the top and the bottom.
